

Current perspectives and challenges for landscape research, planning and development

50 years after the Geographer's Day in Kiel, 'landscape' is again a topic in geography (as is the case with many neighbouring sciences), the essentialisations that were intensively criticised at the time can only be found in current social-scientific landscape research as an object of research, and current human-geographical landscape research, with its mostly constructivist basic positions, has once again become connectable to current human geography.

The conference "Current perspectives and challenges of landscape research", jointly organized by the Arbeitskreis Landschaftsforschung and the Deutsche Akademie für Landeskunde (DAL), reflects the current state of landscape research. Theoretical considerations on landscape understanding are also made, concepts are discussed, empirical results of landscape research are presented and, last but not least, perspectives for landscape research are determined.
